All participants and their parents/guardian(s) agree to read all materials sent to them, and complete all required forms. Participants must arrive and depart on the scheduled arrival/departure days. Arrivals/departures on dates other than specified will not be accommodated without prior approval of the Camp Director.

Our programs are open to boys and girls of high character, and we do not discriminate on the basis of race, creed, color, national origin or sexual orientation. We do, however, reserve the right to refuse admittance.

It is understood and agreed by the student and parents that there shall be no smoking or use of smokeless tobacco and no drinking of alcoholic beverages at any time during attendance at the ESL Summer Program. It is further understood and agreed that there will be no use of, possession of, or involvement with marijuana, narcotics or controlled substances, or any drug equipment or paraphernalia or alcohol container(s). **Failure to comply with this policy will result in immediate dismissal from camp without refund of tuition.**

Deposit

To secure student's enrollment in the Summer ESL Program, a **non-refundable** deposit of **\$300** is due by May 1, 2007. The deposit will be applied against the tuition.

Tuition

Tuition fees for the Summer ESL Program are as stated on the front of this form. Fee includes tuition, room and board, authorized use of school equipment, transportation for required program activities, food and lodgings on group Field Trips, and program materials.

Student Account

A student account deposit of \$200 is due by July 1, 2007. This account is for incidental charges not included in the tuition. Depending on enrollment, possible charges include:

- Purchasing snacks in the student store.
- Photography \$50/week
- Horseback riding \$50/week
- Ceramics \$25/week

At the conclusion of the program credit balances will be refunded.

Agreements

I/We (hereinafter "I") understand that I am reserving a place for this student for the entire session(s) as indicated on the front of this form and that I will be responsible for the full session's tuition, unless the school is notified in writing by June 1, 2007. I agree that my obligation for the full program's tuition fees will not be reduced if the student is dismissed or leaves for any cause, since I understand that such dismissal or leaving will not materially reduce the Program's costs or permit the Program to recoup lost income. I further agree that payment of the program tuition is therefore the fair and reasonable measure of the liquidated damages, which the Program would otherwise suffer in such event.

Program Insurance

All of our activities are designed with safety considerations first. However, accidents do occur even under the closest supervision. Verde Valley School ESL Summer Program carries coverage through a private insurance company, please call the Business Office for more information.
