

# **Agreement for Indemnification and Release of Liability**

The enrolling Student ("Student") and/or the Student's parent or legal guardian acknowledge and understand the following:

1. We have read the Verde Valley School Student Handbook. We understand and agree to comply with the Handbook.
2. We understand that the goal of the Verde Valley School ("School") is to educate students for college and for life. In connection with this goal, the School sponsors a variety of activities, many of which are summarized in the Handbook and include team sports, horseback riding, rock climbing, fitness, martial arts, and camping. We understand that these activities may involve a risk of injury, other harm or damage to the Student and/or Student's property.
3. We understand that Student may engage in activities on- or off-School campus. Some activities may be sponsored by the School, while others may not be sponsored by the School.
4. The student willingly agrees to comply with terms and conditions for participation in all activities. If I observe any unusual significant hazard(s) during my presence or participation I will remove myself from participation and bring such to the attention of the nearest instructor or school employee immediately.
5. We understand that the Student may be engaging in activities that involve a risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from Student's own actions, inactions or negligence, but the actions, inactions, or negligence of others, including the School and its agents, employees and affiliates, or equipment Student may use. Further, there may be other risks not known to Student and/or Student's parent or guardian or not reasonably foreseeable.
6. By signing below, Student and/or Student's parent or legal guardian, assume all of the risks relating to the activities set forth in the Handbook and any activities in any way relating to the School. Student and/or Student's parent or legal guardian accepts personal responsibility for any damages following any such injury, permanent disability, and death or property damage.

7. The following sports and/or activities require informed, individual consent. Please read each carefully and indicate your permission, or lack thereof, for your child to participate in each sport/activity.

**HORSEBACK RIDING:** I understand that horseback riding is classified as a rugged adventure recreational sport activity and that there are numerous obvious and non-obvious inherent risks despite all safety precautions. Further, I agree that my child and/or legal ward has been notified that protective headgear must be worn by the child while riding or working with horses.

**OFF CAMPUS TRAVEL:** I understand that risks include, but are not limited to travel, injury and damage to property. In the event the Student travels without such required identification, we understand and agree that the Student, not the School, will be responsible for the Student's well-being.
